**Directions from Denver:** (186 miles): Take I-70 East to Limon (exit 363). Go southeast on hwy 287/40 to Kit Carson. Take Hwy 40 east to Firstview, just west of Cheyenne Wells. At shoot signs, go North 4.5 miles to CR-34 to intersection with CR-V.

**From East of Colorado:** Take I-70 West to Burlington, CO (exit 437). Go South on Hwy 385 to Cheyenne Wells. Go West on Hwy 40 about 12 miles to Firstview. At shoot signs, go North 4.5 miles to CR-34 to intersection with CR-V.

**From Colorado Springs:** (130 miles): Take Hwy 94 East to Hwy 287/40. Go East on Hwy 287/40 to Kit Carson. Take 40 East to Firstview, just West of Cheyenne Wells. At shoot signs, go North 4.5 miles to CR-34 to intersection with CR-V

# ASSUMPTION OF RISK AGREEMENT

## WAIVER, RELEASE, INDEMNITY AGREEMENT and COVENANT NOT TO SUE

### For The Cheyenne Wells Fire Department LLC.

I assume all responsibility for any and all risk of damage or injury that may occur to my person and/or my property, including theft, as a participant and/or spectator at this event utilizing the discharge of firearms and, in any form size or manner. I hereby waive, release and covenant not to sue Anyone associated with these activities. I agree to indemnify, hold harmless and defend Anyone, from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with any activities, and should any such claim, demand or lawsuit arise or be asserted in any way, I will indemnify and hold harmless Anyone and their agents/employees/volunteers together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including reasonable attorney's fees.

It is the intent of the undersigned and all participants and spectators that all the aforementioned recognize the inherent dangers in playing with, using, discharging, watching, being near or in some proximity to, firearms, mine or others, borrowed, loaned, allowed to use, etc., and that unforeseen accidents can happen, and barring intentional acts, the undersigned and all other participants and spectators agree to each release and waive any cause of action, if any they may have, agreeing to not sue Anyone for any actions that may have led to injury to their person or property, including theft (or injury to their children, if accompanied by the undersigned).

In consideration of being present as a spectator and/or participant at any time, I hereby release and discharge any and all other participants/spectators, the land owner, lessee, tenant, licensee, etc., of the range premises, any, instructors, guides, promoters, sponsors, associations, organizations, distributors, manufacturers, organizing officials, crews, rescue personnel, etc., and their agents/employees, at said event. I furthermore waive for myself and my executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands, and any other actions whatsoever, which I may have or which may arise against Anyone, including my agents, contractors, and subcontractors, their heirs, executors, administrators, assignees and agents from all claims, demands, causes of action, present or future, whether known, or unknown, anticipated, or unanticipated and resulting from or arising out of, or incident to, the undersigned's use (or intended use) of the facilities and equipment at such range. The aforementioned will be referred to herein as "**Anyone**" and I mean ANYONE!

The parents expressly assume all risk on behalf of their children and agree to be liable for any of their intentional/unintentional actions that may harm another attending the event.

Every term and provision of this agreement is intended to be severable. If any portion hereof is found to be invalid or unenforceable, for any reason, the remaining terms and provisions shall continue in full legal force and effect.
